## A. Privacy Policy

Your privacy is important to Singapore Mercantile Co-operative Society Ltd ("SMCS"). In compliance with the provisions of the Personal Data Protection Act 2012 of Singapore ("PDPA"), our Privacy Policy sets out how Singapore Mercantile Co-operative Society Ltd ("SMCS") uses and protects the information provided by you.

Singapore Mercantile Co-operative Society Ltd ("SMCS") respects your privacy and is committed to protecting your privacy. We may change the Policy from time to time by updating this page. You should check this page from time to time to ensure that you are updated with any changes.

### 1. Your Personal Data

In this Privacy Policy, "Personal Data" as defined in the Personal Data Protection Act ("PDPA"), refers to data, whether true or not, about an individual who can be identified from that data, or from that data and other information to which the organisation has or is likely to have access to. - Membership and membership related activities such as membership drives, membership benefits and services, and assisting you with your requests and enquiries;
- Industrial relations related services;
- Training (including overseas courses and workshops);
- Updates on Singapore Mercantile Co-operative Society Ltd ("SMCS") activities and events
- Co-operative Movement's activities and events;
- Market research and customisation of website according to your interests;
- Improve our services and help resolve any problems;
- Compliance with applicable laws and regulations, and
- Any other entities authorised by Singapore Mercantile Co-operative Society Ltd ("SMCS") to carry out the purposes above.

### 4. Disclosure of your Personal Data
