(a) PSLE Education Award

*This award is offered to members whose children have passed the Primary School Leaving Examination (PSLE) 2025 and **are currently studying in Secondary 1 (2026).***

(b) G C E 'O' Level Education Award

*This award is offered to members whose children have passed the GCE 'O' Level/ 'N' Level in year 2025 and are admitted to **first-year at a Junior College/Millennia Institute/Polytechnic/Institute of Technical Education in Year 2026.***

(c) University Education Award

*This award is offered to members whose children are presently in the **first-year courses 2026** at the National University of Singapore (NUS), Nanyang Technological University (NTU), Singapore Management University (SMU), Singapore University of Technology & Design (SUTD), Singapore Institute of Technology (SIT) and Singapore University of Social Sciences (SUSS).*

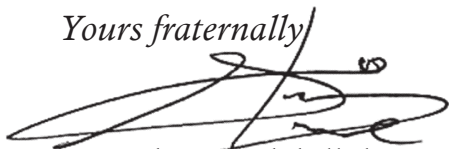
